Martins Corner Rental Update: Ray spoke to KVFD, check zoning, not zoned for that use, received an application for conditional use, KVFD spoke to supervisors they do want it to be a rental, they had a few safety concerns which were addressed, the conditional use application is to go to Elite Cheerleading.

Emergency service recovery billing: Pulled a couple of ordinances to read over and discuss, also there may be a clause in some insurances to pay for fire service, will get back to the board with a proposal.

FD Staffing & Mgmt assistance: Ray had a couple meetings with KVFD, The age of the apparatus drivers is no less than 21 years of age, KVFD has changed the age to 19 years, most EMS

personnel is 18 or 19 years of age. Discussed workmans comp coverage, will make sure to have an audit. Also need to hire full time employees can't continue with just part time employes.

Chuck and Sharon mentioned that Andy Dinniman will be at the Borough on 2/11/19 (will double check this date), let them know ahead of time if someone will be there and the issues they want to discuss, Mr. Dinniman would like to know this before he comes.
